Old Business-

- County contact and D.O.T. about properties on Pleasant Point. Stacy Smith reports that home is not in violation but pile of debris on lot is. 30 days to clean-up. Tree in water is Cama questions. What are the rules for condemning a home? Follow-up needed. Ditches filling up and pipe cleaning needed
- Approval of Budget Petra Watson presents and Toni Evans 1<sup>st</sup> to approve, Denise Fallon 2n unanimous approval. Proposed Budget \$24,114.00
- Don Raymond Update on website information wipoagrandync.com. Minutes, budget, information posted and working on blog!
- Concerns about speeding on WI BLvd. Can we install speed bumps? Issue needs to be addressed with DOT. Signage also may be needed- Solar powered sign is discussed.

## New Business-

- Motion submitted to board by property owner. Letter/Newsletter will be mailed to all WI residents with information related to canal projects and concerns. Also include canal debris, maintenance, etc.

Canals- update on August. 27th meeting Phil Meeting in Washington NC

August 28 meeting summary – permission granted to open Southern access only as alternate access can not be identified as man-made waterway. Permission granted to dredge/open-up canal that is sound access at the end of Dolphin. Unamimous approval from 14 agencies. 5 year permit approved to include interior canals if needed. Key point in permit discussion – ask for renewal so that permit never expires.

Approximate cost of current project - \$35,000 where \$6,000 has already been allotted. Possible financing recommendations include 1. Each POA member pays \$150 2. Canal account with annual fees much like road account
