Reading of Minutes and Adoption: Motion by Pat to accept, 2nd by Curtis.

Treasurer Report and Adoption: Motion Curtis to accept, 2nd by Jack.

Old Business:

Covenants: Update by Don: No updates at this time. Board discuss the cost and formula for charging for road fees. Linear foot frontage has been discussed.

By Laws: Suggestion for changes: None

Street Lights: Street lights that were requested to be turned off, have been turned off. Checking and waiting for Dominion Power to credit and update billing.

Motion made to get pricing for blowing out drains on Walnut Island. Curtis 1st, Don 2nd. Curtis to call county water dept and fire station to see if either would blow out the drains.

Thanks to Curtis for cleaning signs that were vandalize early September. The cleaning saved the WIPOA around \$200 for sign replacement.
