
## Golf Carts in Walnut Island

Is it legal to ride golf carts on public roads in North Carolina? Currituck County law on golf carts can be found in Article V, Chapter 12, sections 12–64 through 12–69.

The basic facts are that street-allowed golf carts are subject to the same requirements as any other vehicle. This means that some golf carts are legal on most North Carolina public roads and others are illegal. North Carolina separates carts into street-allowed and street-legal golf carts and the laws vary according to the type of carts driven.

In most instances only street-legal carts are allowed on public roads. Street-legal carts are subject to the same requirements as other vehicles such as they MUST be registered and licensed. They, also, MUST feature seatbelts, headlights, brake lights, four-wheel brakes, proper insurance, and a vehicle identification number. To operate a street-legal cart the driver must have a valid North Carolina driver's license.



Typically carts, which fall into the street allowed category, reach speeds no greater than 15 mph and do not have break lights, headlights, or seatbelts. Street–allowed golf carts are NOT allowed on public roads! For example, street–allowed golf carts are not allowed to cross any public highway (i.e.US 158).
